I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY AND ALL ACTIVITIES ASSOCIATED WITH THIS ESCAPE ROOM EVENT provided by Roaming Riddle Mobile Escape Games LLC (“Roaming Riddle”) of O’Fallon, Illinois, including by way of example and not limitation, (a) any risks that may arise from negligence or carelessness on the part of the persons or entities being released; and/or (b) from dangerous or defective equipment or property owned, maintained, or controlled by them.

I certify that I understand that participating in this activity has potential risks including but not limited to: (1) use of simple tools; (2) potentially moving or lifting objects of not more than twenty pounds; (3) mental stress and anxiety; (4) being in a reasonably small space with multiple people; (5) negligent participants; (6) possibility of failure to escape the room in the allotted time.; and (7) possibility of falling objects. I have no physical or mental illness that precludes my participation in a safe manner for myself or others. I am not under the influence of drugs or alcohol which impairs my ability to maintain my safety awareness or endangers others.

I acknowledge that this Accident Waiver and Release of Liability Form (“Release”) will be used by Roaming Riddle and that it will govern my actions and responsibilities at said activity. I agree that all officers, directors, employees, staff or authorized agents of Roaming Riddle may, in their sole discretion, determine if it is unsafe for myself or others for my participation to continue, and remove me from the premises by any lawful means.

In exchange for participation in this escape room activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE Roaming Riddle and its members, owners, directors, officers, employees, volunteers, representatives, and agents (“Released Parties”), from and against any and all liability for any loss, damage, injury, expense, demand or cause of action, including but not limited to, liability arising from the negligence or fault of the Released Parties, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or which may arise as a result of my presence or participation in this escape room activity;



(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Released Parties from any and all liabilities or claims made as a result of my presence or participation in this escape room activity, whether caused by the negligence of the Released Parties or otherwise.

I acknowledge that the Released Parties are NOT responsible for the errors, omissions, acts, or failures to act, of any party or entity conducting a specific activity on their behalf. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity. This Release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I grant to Roaming Riddle and any of its assigns, the right to use, publish, and reproduce, for all purposes, including but not limited to marketing purposes, and in any all form of media, my name, images, photos, video footage, and sound materials of me. This grant shall continue perpetually unless I revoke it in writing to Roaming Riddle. I waive the right to receive any payment for Roaming Riddle's use of any of the materials described above for any purpose authorized herein.

I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Roaming Riddle, or its employees, representatives or agents. I agree to pay for all damages to the escape room facilities of the Released Parties caused by any negligent, reckless, or willful actions by me or my family.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL. I acknowledge that I am at least 18 years old. If the participant is under 18 years old, a Parent/Guardian must sign this Release on their behalf and all of the above apply to the minor.
